4. First Aid

Exposure

Swallowed	Do NOT induce vomiting. Wash mouth out with water. Give a glass of water to drink. Call a POISON CENTRE or doctor/physician if you feel unwell.
Eye contact	IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

6. Accidental Release Measures

Containment	If greater than 1000L is stored, secondary containment and emergency plans to manage any potential spills must be in place. In all cases design storage to prevent discharge to storm water.
Emergency procedures	In the event of spillage alert the fire brigade to location and give brief description of hazard. Stop the source of the leak, if safe to do so. Wear protective equipment to prevent skin, eye and respiratory exposure. Clear area of any unprotected personnel. Contain using sand, earth or vermiculite. Do not use sawdust. Prevent by whatever means possible any spillage from entering drains, sewers, or water courses. (If this occurs contact your regional council immediately).
Clean-up method	Use absorbent (soil, sand or other inert material). Rags are not recommended for the clean-up of spills, as they may create fire or environmental hazard. Collect and seal in

Disposal properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services. Mop up and collect recoverable material into labelled containers for recycling or salvage. Recycle containers wherever possible. This material may be suitable for approved landfill. Engineering Controls

PVC or rubber boots must comply with AS/NZS 2210.2 and selected and maintained in accordance with AS/NS2210.1. Remove protective clothing and wash exposed areas with soap and water prior to eating, drinking or smoking. Wash hands after handling.

Respiratory

A respirator when airborne concentrations approach the WES (section 8).
