water. If swelling, redness, blistering or irritation occurs seek medical assistance.

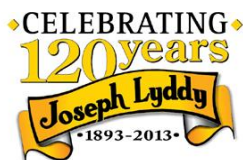

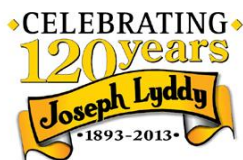
